Pasifika Gold Coast Stall Holders Terms and Conditions

General:

Pasifika Gold Coast will not be cancelled due to bad weather.

All stallholders must hold current public and products liability insurance cover for at least \$10 million dollars. You must provide a copy of this with your application form.

All stallholders must supply their own covered Gazebo or tent structure provided it measures no more than 3metres x 3metres. You will also be allowed to erect a same size structure behind your allocated stall to use as storage for additional stock or as a food prepping area.

Set up time:

Stallholders will be permitted to enter and set up at approximately 5:30am - 7:30am. Cars will be permitted to enter and unload in the designated drop off zones until 7:30am after this AII

CARS MUST BE MOVED from the stall area. Stallholders will

be asked to park their vehicles in the carpark.

All stallholders must be set up and ready by 8:00am, after this time no one will be permitted to set up regardless of circumstances. Please to avoid disappointment take note of the SET UP times.

You will be able start packing up by approximately 5:00pm

Fees:

Once your application is accepted your Stall fee must be paid in full by the 1st of September.

There will be no refunds given after this date due to cancellations.

Allocation of stalls is based on first in first served basis. However Pasifika Gold Coast reserves the right to limit any stalls in a particular category (eg. Foods, clothing etc).

Rubbish:

All stallholders are required to provide their own rubbish bags but can dispose of these in the bins provided. Rubbish of stallholders is not to be disposed of in the bins on the oval or sports fields.

Sales of items:

All food stallholders must comply with Gold Coast City Council guidelines. Cleanliness, safety and hygiene are a must.

No toy guns, cap guns, silly string or any similar items to be sold.

No weapons of any kind or pornography of any sort to be sold.

Power

No power will be provided by Pasifika Gold Coast, however stallholders can provide their own generator as long as it is silent.
